Set a long-term portfolio benchmark and define the intended balance of income and risk.

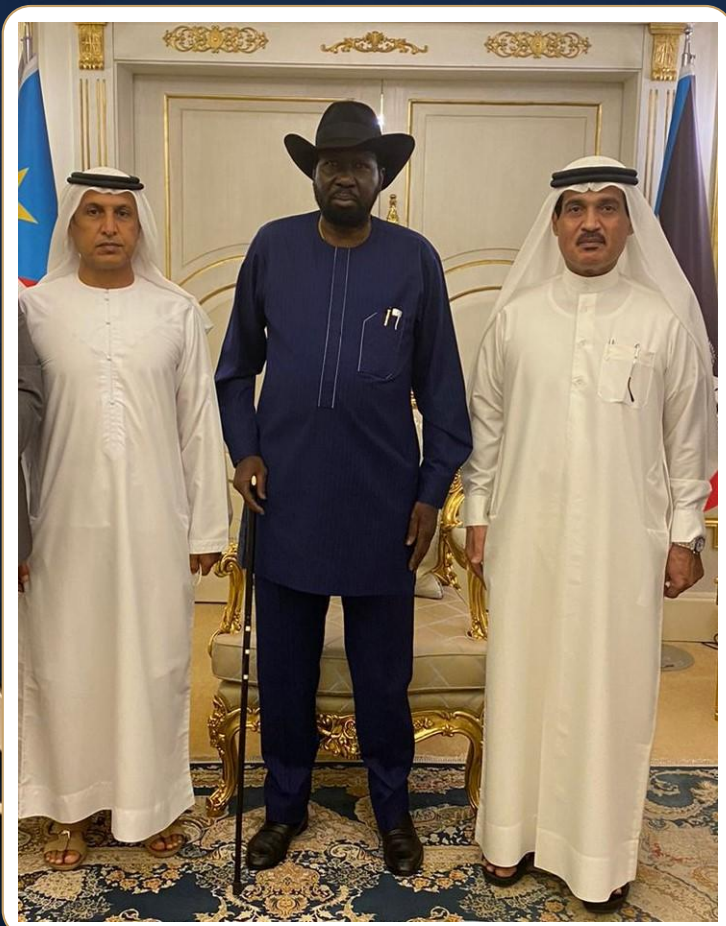
